CREATIVE COMPASS - ARTS CLEVELAND CONTINUED TO UPDATE ITS ONLINE RESOURCE CENTER THAT PROVIDES LOCAL ARTISTS WITH INFORMATION ON SPACE, EMPLOYMENT, FUNDING, INSURANCE, BUSINESS DEVELOPMENT AND ARTISTIC DEVELOPMENT. DURING THE YEAR, 118,306 INDIVIDUALS VISITED THE SITE, THERE WERE 280,437 PAGEVIEWS AND 856 SUBMISSIONS.

ACCESSIBILITY TO ARTS AND CULTURE - ARTS CLEVELAND BEGAN A WORKING GROUP OF ARTS, CULTURE AND DISABILITY SERVICE PROVIDERS TO DISCUSS BEST PRACTICES IN CREATING ACCESSIBLE ARTS AND CULTURE EXPERIENCES FOR PEOPLE WITH DISABILITIES. THE GROUP SHARED AND LEARNED FROM ONE ANOTHER IN AN EFFORT TO BUILD A MORE COLLECTIVE EFFORT AROUND ACCESSIBILITY.

PUBLIC OFFICIALS RECOGNITION BREAKFAST - ARTS CLEVELAND CARRIED OUT ITS ANNUAL EVENT TO CONNECT ARTS AND CULTURE PROFESSIONALS AND ARTISTS TO ELECTED AND APPOINTED PUBLIC OFFICIALS. 175 INDIVIDUALS ATTENDED THE EVENT. TWO LOCAL PUBLIC LEADERS WERE RECOGNIZED FOR THEIR CONTRIBUTIONS TO THE ARTS AND CULTURE SECTOR.
